(Personnel & Legal)

Village Board to move into Executive Session, under New York State Open Meetings Law, Public Officers Law, Article 7 §105(1)(f), to discuss the medical, financial, credit or employment history of a particular person or corporation or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation.
2. Village Board to move into Executive Session, under New York State Open Meetings Law, Public Officers Law, Article 7 §105(1) (h) the proposed acquisition, sale or lease of real property or the proposed acquisition of securities, or sale or exchange of securities held by such public body, but only when publicity would substantially affect the value thereof.
